

Local Youth Club Grant Scheme

If your Youth Club or Youth Group is making an application to Donegal ETB for a grant under the Local Youth Club Grant Scheme, you must submit:

1) a Charitable Status Number

OR

2) a Tax Registration Number

The application form for a Tax Registration Number is attached. There are two easy steps to submitting a Tax Registration Number for your Youth Club Grant application:

1. Print out and complete the registration form, then sent it to:

Office of the Revenue Commissioner Registrations Section High Road Letterkenny Co. Donegal

Revenue will issue you with a letter containing a Tax Registration Number.

2. When you receive the letter from the Revenue Commissioner, you <u>must</u> forward a copy of that letter to this office.

Complete all parts of this form as required in BLOCK LETTERS, sign the declaration and return it to the organisation's Revenue District Office. Without accurate information the registration will be delayed and/or you may experience delays with regard to the documentation you require.
