

<u>Annual Report on Protected Disclosures for 2023</u>

Section 22 of the Protected Disclosure Act 2014 requires public bodies to prepare and publish, by 31 March in each year, an annual report in relation to the previous year.

Donegal ETB confirms that it has established internal reporting channels and procedures in accordance with the Act.

Pursuant to Section 22 of the Protected Disclosure Act 2014, Donegal Education and Training Board confirms that for the period 1st January 2023 to 31st December 2023, no protected disclosures were received and therefore no action was required to be taken by Donegal ETB.
